II. This contract covers the stallion LCK LUKE SKYWALKER,

AMHA# 189664 ("the stallion") and the mare _____

III. Mare owner agrees to pay the following expenses:

A. The stud fee of \$ 1000, payable to Lisa C. Keller, 344 Campbell Rd. York, PA. 17402, plus \$ 250 / collection and shipping payable to Dutch Country Stables.

B. All veterinary and/or technician charges related to breeding the mare are due before the mare leaves the breeding farm.

C. Mare care of \$ 10.00 per day or \$ 12.00 per day with a foal at her side.

D. Mare owner acknowledges that both the mare and foal must be DNA typed by the AMHA prior to registration, and any foal conceived in any manner not in compliance with this contract may not be eligible for registration. The stallion owner does not assume any responsibility or obligation for the foal except reasonable assistance in the provision

of information and the execution of forms, provided that all payment terms have been fulfilled.

IV. Mares should be in good health and serviceably sound. The mare must be halter broke.

Note: We reserve the right not to breed any mare we determine to be unfit or unsafe.

V. If the mare named in paragraph II. Does not settle after 3 estrous cycles, the mare owner may substitute a different mare ("substitute mare"), which must be fully identified and approved by the stallion owner.

VI. If the mare or substitute mare fails to settle or produce a live foal, the mare owner may breed in the following season using either the mare or substitute mare without any additional stud fees. "Live foal" as used herein is defined as a foal that stands and nurses. In any event, all breeding rights under this contract shall expire two (2) years after the date of the first service to the mare named in this contract.

VII. This contract shall be null and void, and the stud fee shall be returned to the mare owner if the mare dies before the first service of the mare. If the stallion dies or becomes unfit for service, the stud fee will be refunded.

VIII. During the time that the mare is in the custody of Steven Glick, the stallion manager, the stallion owner, and/or Dutch Country Stables shall not be liable for any sickness, disease or injury which may be suffered by the mare and/or foal at her side.

IX. The 2023 breeding season shall be from March 15 to July 1, 2023.
