Terms and Conditions of This Stallion

1. The non-refundable booking fee of **\$250** is due at the signing of this contract. The remaining balance of the service fee is due before semen is shipped. No mare will be shipped to unless the signed contract is complete, signed, returned, and service fee is paid.
2. With shipped frozen semen, there will be a **\$250** shipping/collecting fee each time the semen is shipped. With fresh, cooled semen, there will be a **\$325** shipping/collecting fee each time the semen is shipped. Frozen or fresh, cooled semen should be ordered 3 days prior to shipment. Shipping takes place on Mondays, Wednesdays, and Fridays. Shipping containers need to be returned within 10 working days of shipment date. A **\$10** per day late return fee will be billed to the mare owner until container is returned.
3. Showcase Stables is not responsible for lost, delayed, or damaged semen during shipment.
4. Showcase Stables will diligently try to settle your mare. You will have a 1-year return privilege with same mare and same owner during the next breeding season.
5. Substitute mare is not allowed without prior written consent of Showcase Stables and Alan Walton.
6. This contract shall be null and void, and the purchaser shall be entitled to a refund of any amount paid to Showcase Stables hereunder if the stallion should die or become unfit for service prior to servicing the mare in the present breeding season. This does not apply to donated services.
7. If the mare owner fails to pay any fees due to stallion owner or agent under the terms of this contract the mare's name in question will not be added to the AMHA Stallion Service Report Form due at the end of each year until all debts are paid including all penalties for late filing of the AMHA Stallion Service Report Form.
